- To communicate with users Sending newsletters, updates, or responding to inquiries.
- **To analyze user behavior** Using analytics tools to understand traffic trends and improve engagement.
- To maintain security Preventing fraud, cyberattacks, and unauthorized access.
- **To comply with legal requirements** Fulfilling obligations under applicable data protection laws.

We do not sell or rent your personal data to third parties for marketing purposes.

3. Cookies and Tracking Technologies

We use cookies and similar technologies to:
